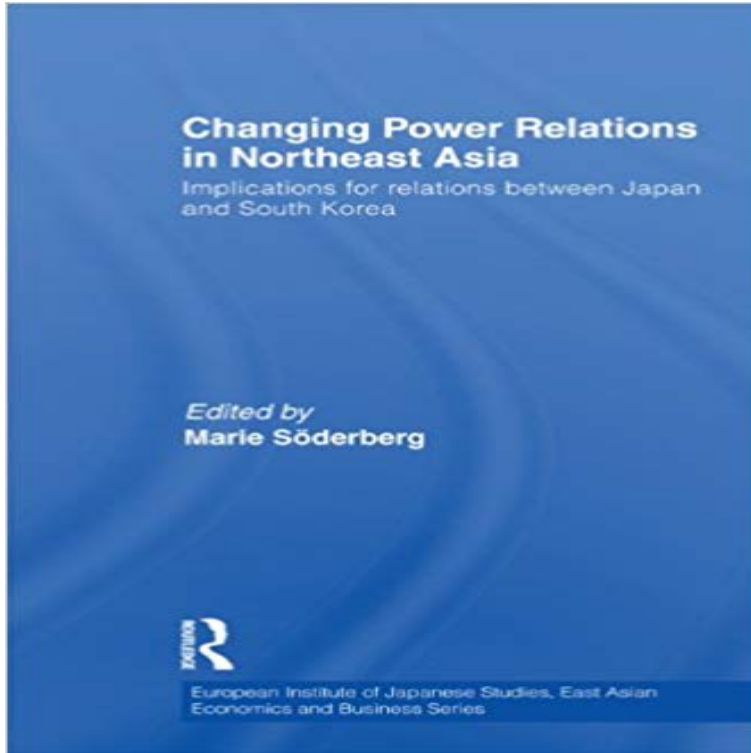


Changing Power Relations in Northeast Asia: Implications for Relations between Japan and South Korea (European Institute of Japanese Studies East Asian Economics and Business Series)

Both have security treaties with the USA, they share security concerns when it comes to the North Korean nuclear threat as well as the rise of China, which at the same time has become the largest trading partner for both. Japan and South Korea also share similar values, customs, cultures and languages. All this would make it logical for them to have a strong cooperative bilateral relationship. Yet this is still not the case. The contributors to this book examine how the relationship is affected by the changing power relations in Northeast Asia and find a most complex situation. Understanding how Japan and Korea interact is central for anyone that wants to understand the politics of East Asia.
