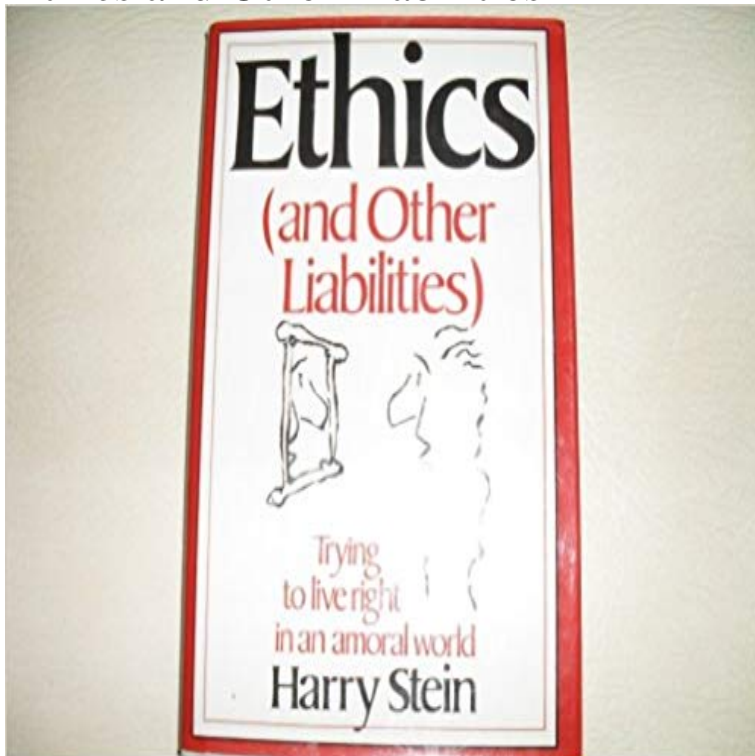


## Ethics and Other Liabilities
